

Encina Wastewater Authority (EWA) is a wastewater treatment agency in Carlsbad, California. We serve over 370,000 residents and regulate approximately 600 business in a 125-square-mile service area in northwest San Diego Coun-ty. Six public agencies own EWA through a Joint Powers Agreement that facilitates cost sharing and enables economies of scale that the individ-ual member agencies could not achieve independently. These member agencies are the City of Carlsbad, the City of Vista, the City of Encinitas, the Vallecitos Water District, the Buena Sanitation District, and the Leucadia Wastewater District.

Carlsbad is a seaside community of 39 square miles, nearly 40% of which is dedicated to open space. In this role, you will be responsible for performing a variety of professional inspection, investigation, analytical, and reporting duties to protect human health, the collection system, POTW, and Waters of the United States from toxic discharges.

The Ideal Candidate

The ideal candidate for this position has a Bachelor's degree in natural or enviornmental science, engineering, or a closely related field from an accredited college or university.

Source Control Inspector I: Will have three years of experience in the field, and obtain possession of an Enviornmental Compliance Inspector Grade I Certification from the California Water Enviornment Association (CWEA) within the first year of appointment.

Source Control Inspector II: Will have four years of experience in the field, and possession of an Enviornmental Compliance Inspector Grade II Certification from the California Water Enviornment. An Enviornemental Complaince Inspector Grade III Certification from CWEA is desired.

Possession of a non-restricted California Driver's License and successful completion of a pre-employment physical examination, drug screen, and background checks will be required at the time of appointment.
